1. ADOPTION OF AGENDA

The agenda was approved as circulated.

2. DISCLOSURES

BCFC advised of procurement activities to retain consulting firms that might be engaged during Performance Term Five.

BCFS advised that there was nothing new to report.

3. RECORD OF MEETING

a. December 10, 2019 Quarterly Meeting

b. Action Items

The record of the December 10, 2019 quarterly meeting and action items were reviewed and approved.

4. FISCAL 2020 – COMPLIANCE REPORTS

a. Q3 Core Service Levels

Reports prepared by BCFS on its performance against core service levels as set out in the Coastal Ferry Services Contract for the quarter ended December 31, 2019 were reviewed

and discussed. The reports indicate BCFS' compliance with the core service level requirements in the guarter.

b. Q3 Price Caps

A report prepared by BCFS comparing the quarterly average fare index with the quarterly price cap index by route group for the seven quarters ended December 31, 2019 was reviewed and discussed. The report indicates BCFS' compliance with all regulatory requirements in respect of the average fares charged in the quarter.

d. Q3 Drop Trailer

BCFS' calculation of its average drop trailer tariff for the quarter ended December 31, 2019 was reviewed and discussed. The report indicates BCFS is in compliance with Order 16-01.

5. FUEL DEFERRAL ACCOUNTS

a. Balance at January 31, 2020

A report prepared by BCFS on the deferred fuel account balances as at January 31, 2020 was reviewed and discussed. The report indicates that BCFS has complied with the terms and conditions for fuel deferral accounts set out in Order 15-03A.

BCFS informed BCFC of its intention to implement a fuel rebate of 1.5 percent across all routes due to recent declines in fuel costs.

b. Forecast

BCFS' projections for the regulatory account balances were reviewed and discussed.

c. GST Appeal Legal Costs – Status

BCFS provided an update on its appeal of the Canada Revenue Agency's tax assessment disallowing any recovery of goods and services taxes through input tax credits for fuel costs. BCFC confirmed that legal fees arising from this appeal may be charged by BCFS against the fuel deferral account.

4. FISCAL 2020 – COMPLIANCE REPORTS (Cont'd)

c. Q3 Feedback and Engagement Report

BCFS' engagement activities described in the feedback and engagement report for the quarter ended December 31, 2019 were reviewed and discussed, inclusive of opportunities for further improvements to the report.

6. PERFORMANCE TERM FIVE

a. Performance Reviews - status

There was a discussion of the performance review currently under way with respect to

BCFS's complaints process.

b. Price Cap Compliance Index Reset

There was a discussion of BCFC's decision regarding the reset of the price cap compliance

index for Performance Term Five.

c. Capital Plan – update

BCFS outlined some of the steps it is taking to ensure that capital costs remain within the

overall approved amount for the 12-year capital plan. The focus has been on maintaining

safe and reliable service.

d. Percent Efficiency Target - Possible Metrics and Reporting

There was a discussion with respect to BCFS' progress in developing an efficiency target as

required by Order 19-04 regarding the final decision on price caps for Performance Term

Five. BCFC noted that the intention is to be able to track BCFS's progress in realising

efficiencies, which may be found by either reducing costs or improving revenues.

7. FLEET STANDARDIZATION

BCFS reviewed the financial and operational benefits of fleet standardization. There was a

discussion of how to quantify these benefits, whether they be a result of efficiencies or

cost-avoidance.

8. GOVERNMENT ENGAGEMENT

BCFS' recent engagement activities with the provincial government and with First Nations

were reviewed and discussed.

9. VESSEL ELECTRIFICATION – OVERVIEW

BCFS reviewed the opportunities and challenges with potential electrification of various

classes of its fleet. BCFS noted that the electrification of vessels is not within the current

capital plan. There was a discussion of how vessel electrification is capital-intensive for

vessels and infrastructure, and supporting funding from external sources will be required

to move vessel electrification forward.

10. REGULATORY FILINGS

a. Conditions Status Update

BCFS' progress in meeting the conditions set out in BCFC's orders under the *Coastal Ferry Act* was reviewed and discussed. A listing of BCFC orders, commencing with Order 13-01, that have had all conditions satisfied as of March 12, 2020 is attached to these minutes for reference.

With regard to Order 19-02 (A Major Capital Expenditure for four Island Class Vessels and one Salish Class Vessel) dated January 7, 2019, BCFS noted that anticipated capital expenditures for individual terminals vary from BCFS' application but altogether are within the approved overall amounts. In addition, BCFC has reviewed various correspondence received from BCFS and confirmed that condition 1(b) is satisfied.

b. Section 55 Guidelines - status

c. Public Input Process – status

BCFC noted that the updated guidelines for applications for approval of major capital expenditures under section 55 of the *Coastal Ferry Act*, and the new guidelines for applications for participation costs of eligible organizations under section 46.2 of the same Act, have been finalised and published on BCFC's website.

d. Fare Flexibility and Digital Experience Initiative (FFDEI)

BCFC reviewed next steps regarding BCFS' filing seeking approval of an increase in the amount previously approved under section 55 of the *Coastal Ferry Act* for the major capital expenditure for FFDEI.

e. Potential Section 55 Filings – timing

BCFS provided an update regarding timing related to the potential filings to seek approval of major capital expenditures under section 55 of the *Coastal Ferry Act*.

11. UPDATES

a. Traffic Trends

BCFS provided an update with regard to vehicle and passenger traffic trends.

b. Efficiency Metric – AEQ Nautical Mile

BCFS described its progress in developing an efficiency metric based on the automobile equivalent (AEQ) nautical mile.

c. Island Class Vessels Phase 1

i. Full Electrification - Status

d. Salish Class Vessel 4, Island Class Vessels Phase 2 and Terminals

e. New Major Class Vessel Program

BCFC accepted as circulated the update for the Vessel Replacement Program, and a general discussion followed.

f. Major IT Projects

i. FFDEI - Transition to Sustainment

BCFS provided updates for the Automated Customer Experience program and FFDEI, including the arrangements made to transition FFDEI to sustainment.
